## Survey 1 - Response Highlights



- 100% of respondents said the grant award was important in enabling their 'project' to go ahead
- 92% of respondents said they felt the Community Grants Scheme was essential/important for landscape development and conservation in the South West Peak area
- Over 80% of respondents said the application process has helped to build their confidence/capacity to apply for other sources of funding
- 74% said they found the help from the grants team was very valuable/valuable

## Survey 2 - Response Highlights



- 95.6% of respondents feel that their project supports the SWPLP Scheme objective of conserving, protecting, and/or enhancing natural, built or cultural heritage
- 92% of respondents said they felt the Community Grants Scheme was essential/important for landscape development and conservation in the South West Peak area
- 91% of respondents feel that their project supports the SWPLP Scheme objective of helping people learn about their natural, built or cultural heritage AND the objective of helping communities celebrate the natural, built or cultural heritage
- 87% of respondents said they felt that their project supports the SWPLP Scheme objective of increasing people's awareness and enjoyment of the South West Peak area for residents and/ or those working in or visiting the area?

#### Comments:

- "Our project into the South Peaks has given the young carers experiences they would never have normally been given at a time they needed it the most. We are proud of the fact we gave them a positive experience they will remember into adult life and hopefully find the inspiration to explore the countryside as adults. 














## 5. How important was the SWPLP grant in enabling your project to go ahead? <sup>25 responses</sup>









Gathering data and evidence of match funding / receipts is not usually a requirement for many funds and we as a YMCA have that information if funders require a spot check but it is not usually a mandatory part of claiming.

A former colleague submitted the original bid prior to leaving the organisation. I took over responsibility for ensuring the project completed successfully. The original bid was completed in an incoherent way, with unrealistically ambitious outcomes.

It was unclear that the total amount claimed for would need to be accounted for in order to claim the SWP grant. One would expect only the sections relevant to the SWP grant given would need to be accounted for in terms of invoices. The way the grant is paid out in stages does not relate directly to the expenditure incurred, which was confusing.



SWPLP is a group of organisations working to restore, protect, and improve the landscape of the South West Peak, which with the help of the National Lottery Heritage Fund supports projects with grant funding. As SWP is a local organisations it is able to provide help and assistance in grant applications for local projects that meet the aims and requirements of the SWP.

The South West Peak Landscape Partnership Scheme is an umbrella organisation that brings a number of partners together to maximise footfall, learning, experiences and volunteering in the geographical area of the South West Peak.

Aware of lots of other groups who have benefited

The scene is helping to revitalise the community, building bridges and helping innovation.

It's a group which aims to improve and protect the landscape while building stringer communities within it

The South West Peak Landscape Partnership Scheme is an umbrella organisation that brings a number of partners together to maximise footfall, learning, experiences and volunteering in the geographical area of the South West Peak.

Scheme is rooted in valuing the culture and people of the Staffordshire Moorlands and white Peak areas. I valued the advice and dialogue with advisers of SWPLPS - positive, approachable, informed and enabling. Our Village Hall underpins so much of the social interactions within the rural community. It is a 96 year old building and a vital element for our White Peak village. We are ten miles from an urban centre and the Scheme readily recognises the role the building plays to our community.

I felt it was a very important mechanism to encourage development projects in the South West Peak.

They have been very helpful in suggesting areas of improvement for the hall.

Good opportunity to provide people with access to a space they wouldn't normally connect with

It has been a beneficial and timely scheme, in my opinion. One reason is that much of the area embraced by the Scheme has been 'off the radar', a quiet backwater not normally attracting the attention of 'external' agencies, in spite of large parts being within the boundary of the Peak District National Park. The Scheme has calmly promoted opportunities for the enjoyment, appreciation and understanding of the South West Peak's landscape qualities and heritage values. It has also provided mechanisms to support the people who live there, as well as those who visit it, and it has also brought closer ties between several of the agencies operating in South West Peak. I am sorry the Scheme will end; I think a problem with time-constrained projects, especially in rural areas, is that they often lack continuity/sustainability. Hopefully, at least some of the mechanisms put in place can continue in one form or another.

The principle is excellent but sometimes the boundaries around the work feel constraining eg it could recognise that the Moorlands area draws in people from towns like Leek and Buxton and allowing engagement activities to work in those areas makes a big difference to spreading information about the area (in our project we had to work strictly to the boundaries - it was very frustrating when a mile or two would allow access to many more people - other groups and activites did not seem to be so constrained)

The SWP LPS seems to be useful in engaging local groups in the SWP area.




#### 1. Did your project involve setting up a new community group?








2. Was it a new project that your group were undertaking or part of an existing project?







3. Did the project attract new members or volunteers to get involved with your group/activity?








4. If your project attracted new members and/or volunteers were these members/volunteers local residents?





We gathered a great quantity of local historical material that might otherwise have remained dormant or lost, particularly in the form of stories/memories. We learnt how to access archived material. We became more skilled at 'interviewing' elderly people. We learnt more about the pros and cons of compiling written and spoken material into a suitable format for publication.

We had a good community spirit, during the decorating and afterwards

Both group members and beneficiaries gained new knowledge about the surrounding area and outdoor activities. Given that our project rested on helping children and young people with special educational needs gain access to the outdoors, children tried new activities in these contexts. This not only helped improve their confidence but they learnt new skills as well, such as climbing.




#### 8. To what extent has your project enhanced the sustainability of you group?








9. To what extent has your group's involvement in the SWPLP (South West Peak Landscape Partnership) enhanced the sustainability of your group?















We have enhanced the use of the village hall, and thus the enjoyment of those who use it.

We have facilitated people's access to less well known footpaths in the SWP.

The huge amount of money needed to complete our project was a joint effort between local fundraising and grants, we are proud that our community was able to raise such an amount to create a viable future for the most significant building in our village.

We hope we are improving recognition of Flash as the highest Village in the Uk and what the surrounding area offers to walkers, cyclists, holidaymakers and local residents

I believe the project was primarily of relevance/interest to a specific community within South West Peak. I have been told by many people who live within that community, or those who used to live in it, now scattered around the UK and elsewhere in the World, that the outcome provided much joy, pleasure, and happy memories of times past. It is a record for posterity, much of which would almost certainly have been lost without engaging in the project.

Our grant helped to pay for new lighting and painting of the local church

Our project plays a remarkable part in increasing the confidence of children and young people (CYP) with special education needs through the outdoors. We allow CYP to gain access to the outdoors and try activities they may not have tried before. This is extremely helpful not just in confidence-building but allowing them to have fun, push their comfort zone boundaries and help with their mental well-being. Both the children, teachers and their families have reported back to us how important it has been to show where the children need extra support and their capabilities.

Taking young people to wild places in a part of the country they have never been. Our young carers miss out on exploring and seeing larger and more rugged places. Our project into the South Peaks has given the young carers experiences they would never have normally been given at a time they needed it the most. We are proud of the fact we gave them a positive experience they will remember into adult life and hopefully find the inspiration to explore the countryside as adults. Our favorite quote from a young person was "I haven't felt this happy for ages".

It opened up the church building to visitors to the area providing support particularly during the covid lockdown

The feedback from users and beneficiaries who always comment on how much they've enjoyed the environment and wildlife around them when they visit, in particular those people who don't normally have opportunities to engage with and enjoy nature, wildlife and green spaces

Helped us to preserve a listed building

We tell people that the project has secured the long term viability of the property for at least the next 50 years if not longer. Just look at how good the building looks and how it blends in with the surroundings. We let people know how proud we are of the success of the project and the support we received from the SWP and National Heritage Lottery Fund.
